"The mission of Maine Medical Center's Department of Vocational Services is to contribute to the health and wealth of the community by supporting individuals to overcome barriers and achieve meaningful employment. Our vision is to provide leadership and promote systemic change by delivering quality vocational services, fostering access, and creating community alliances that support people.

"We have been working to assist people with disabilities in Maine to obtain and advance in employment for decades. One way we do this is by providing Benefits Counseling Services, also known as Work Incentives Planning and Assistance; we are specifically trained on Social Security's work rules, and talk daily with Social Security disability beneficiaries who want to work. They are concerned about losing their financial and health insurance safety net while they work.

"Over ten percent of Maine's working-age population receives a disability benefit from the Social Security Administration. At the same time, Maine is facing an imminent workforce shortage. Considering that medical and behavioral health treatment in 2015 looks much different than it did when Social Security disability was created in 1956, there is a need for state, federal, and private disability benefit systems to collectively redefine the all-or-nothing nature of eligibility for benefits when a beneficiary works. Senator King's leadership on this topic is timely and necessary for Maine to mobilize this skilled and able workforce."
