United States shall, after appropriate public notice and 2 opportunity for comment in accordance with section 2071 3 of title 28, United States Code, issue a code of conduct 4 for the Chief Justice of the United States and justices of 5 the Supreme Court of the United States. 6 (b) Publication.—The Supreme Court of the 7 United States shall publish the code of conduct required 8 under subsection (a) on the website of the Supreme Court, which shall be available to the public. 10 (c) Designated Individual.— 11 (1) IN GENERAL.—The Supreme Court of the 12 United States shall designate an individual, includ-13 ing an employee, to process complaints containing 14 allegations that the Chief Justice of the United 15 States or a justice of the Supreme Court has en-16 gaged in, or is engaging in, conduct that is— 17 (A) prejudicial to the administration of 18 justice; or 19 (B) in violation of Federal law or the code 20 of conduct established under subsection (a). 21 (2) Obligations.—The Chief Justice of the 22 United States and the justices of the Supreme Court 23 of the United States may confer with the designee 24 described in paragraph (1) on the obligations of the 25 Chief Justice or justice, as applicable, under the

1 code of conduct required under subsection (a) and 2 section 455 of title 28, United States Code. 3 (3) Report.—The individual designated under 4 paragraph (1) shall publish on the website of the Su-5 preme Court of the United States a report that de-6 scribes— 7 (A) the complaints described in paragraph 8 (1), with the names of the complainants 9 anonymized; and 10 (B) any steps taken to remedy the alleged conduct. 11 12 (4) Investigations.—The Marshal of the Su-13 preme Court of the United States, after consultation 14 with the Chief Justice of the United States and the 15 designee described in paragraph (1), may commis-16 sion, on a reimbursable basis, Federal agency per-17 sonnel who serve in investigative roles, or businesses 18 that contract with the Federal Government to carry 19 out investigative work, to assist the Marshal in car-20 rying out investigations to determine whether the 21 Chief Justice of the United States, a justice of the 22 Supreme Court, or an employee who reports to a 23 justice of the Supreme Court, as applicable, has en-24 gaged in, or is engaging in, conduct described in 25 paragraph (1).
