Dear Chairman Isakson and Ranking Member Tester:

As you develop legislation to ensure our nation's veterans are able to utilize the Veterans Choice Program for the remainder of fiscal year (FY) 2017 and for FY 2018, we ask that you include in that legislative package authorization of 27 Department of Veterans Affairs (VA) medical facility leases. Authorization of these leases has strong bipartisan support from multiple states and is necessary to enable VA to deliver vital care and services to veterans across the United States.

A 2012 change in budgetary scoring of VA's major medical leases by the Congressional Budget Office has hampered the authorization of these important leases. Due to the change, the lease authorizations receive large, up-front direct spending scores covering the entire life of the lease, even though actual spending would not increase and the leases are subject to annual appropriations. This scoring issue has prevented Congress from easily authorizing major medical leases for the past several years. The last VA medical facility leases authorized by Congress were in 2014, with the enactment of the *Veterans Access, Choice and Accountability Act*, which established the Choice Program.
