

**Congressionally Directed Spending Requests — Agriculture, Rural Development, and Food and Drug Administration**

**Recipient Name:** Harrison Food Bank

**Project Location:** Cumberland County, ME

**Project Purpose:** The requested funds are to finish the Harrison Food Bank and Community Center, including interior and exterior upgrades. Facility will also serve as a shelter and food distribution hub for the town.

**Amount Requested:** \$388,000

**Requesting Member:** Sen. Angus S. King, Jr. (ME)

**Recipient Name:** Maine 4-H Foundation

**Project Location:** Cumberland County, ME

**Project Purpose:** Maine 4-H, working with the University of Maine, proposes to buy the Magic Lantern in Bridgton, ME to expand 4-H programs with local schools and afterschool programs. Topics will be focused on leadership development and small business, entrepreneurship, engineering and STEM, the visual and performing arts, marketing and digital advertising, and culinary arts. Maine 4-H plans to transform the building into an Innovation Lab and Learning Center to support the students in Bridgton and the surrounding communities.

**Amount Requested:** \$450,000

**Recipient Name:** Millinocket Memorial Library

**Project Location:** Penobscot County, ME

**Project Purpose:** The library seeks funding for Phase III of the library renovation project, which includes the addition of a roof canopy to create an outside children's space, exterior site work, a solar array on the roof, and external signage.

As part of our town's resilient response to the challenges of the future, the federal funding will support foundation and groundwork, new HVAC, ADA bathrooms, new entrances, and interior remodeling to fully upgrade the historic building and equip it in such a way that both in-person and hybrid/virtual gatherings are possible.

The facility was built in 1995 and is beginning to show its age. As part of the upgrades, the facility would be made ADA-compliant.
