

Congressionally Directed Spending Requests — Commerce, Justice, Science, and Related Agencies

Recipient Name: Bigelow Laboratory for Ocean Sciences

Project Location: Lincoln County, ME

Project Purpose: Bigelow seeks CDS support to cover the costs of their free BLOOM programs (Bigelow Laboratory Orders of Magnitude) -- a week-long oceanography immersion camp for Maine high school juniors bringing 16 Maine high school juniors to Bigelow campus from across the state, one from each county for an intensive oceanography camp designed to improve STEM education in Maine.

Amount Requested: \$89,000

Recipient Name: City of Portland Police Department

Project Location: Cumberland County, ME

Project Purpose: The Portland, ME Police Department proposes to launch an alternative response program modeled upon successful programs from other parts of the country. The PART project will provide a non-law enforcement response to calls for service triaged through the Portland Regional Communications Center and determined safe and more appropriate for a social service response.

Amount Requested: \$658,000

Recipient Name: Gulf of Maine Research Institute

Project Location: Cumberland County, ME

Project Purpose: Gulf of Maine Research Institute's Climate Center project will support resilient and thriving waterfront economies all along Maine's coasts and enhance planning for a future with higher seas, stronger storms, and warming and acidifying waters. The project will provide communities with actionable plans aligned with and in support of Maine Won't Wait, the state's climate action plan.

Amount Requested: \$650,000

Project Purpose: To fund the Department of Marine Resources Conservation Framework, a strategy to reduce mortality and serious injury of right whales incidental to the operation of ten Northeast fisheries, and to support Maine's heritage lobster industry as an economic driver.

Project Purpose: The Midcoast Council of Governments is seeking funding to support local police department equipment purchases for multiple departments in the region.

Recipient Name: Roux Institute at Northeastern University

Project Location: Cumberland County, ME

Project Purpose: The CDS funding would support the development of the Advanced and Additive Manufacturing (AAM) Center at Brunswick Landing. The Roux Institute in collaboration with Kostas Research Institute, (a partnership model with university researchers, early-stage companies, mature industry) will finance the operational costs and hiring key Center staff, and supporting workforce development and educational programs.


